FULL ADULT – **COST \$120** This membership is for 1 adult. Membership includes 1 league with a max value of \$60 each. This is not refundable or transferable toward anything else. Open shoot time is free. 1 key for the indoor and 1 key for the outdoor will be provided.

LIMITED ADULT - COST \$25 This membership is for one adult. Membership includes reduced rate of \$4 per hour at indoor range and free shooting and a key to the outdoor range.

JUNIOR – **COST \$5** This membership is for one child through the age of 17. Indoor shooting cost is reduced to \$2 an hour. You must be always accompanied by an adult.
